	4. FIRST AID MEASURES
Inhalation:	Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. If symptoms develop and persist, get medical attention.
Skin contact:	Do not pull bonded skin apart. Soak in warm soapy water. Gently peel apa using a blunt instrument. If skin is burned due to the rapid generation of he by a large drop, seek medical attention. If lips are bonded, apply warm wate to the lips and encourage wetting and pressure from saliva in mouth. Peel o roll lips apart. Do not pull lips apart with direct opposing force.
Eye contact:	Immediately flush with plenty of water for at least 15 minutes. Get medical attention. If eyelids are bonded closed, release eyelashes with warm water covering with a wet pad. Do not force eye open. Cyanoacrylate will bond t eye protein and will cause a lachrymatory effect which will help to debond tl adhesive. Keep eye covered until debonding is complete, usually within 1-3 days. Medical attention should be sought in case solid particles of polymerized cyanoacrylate trapped behind the eyelid caused abrasive damage.
Ingestion:	Ensure breathing passages are not obstructed. The product will polymerize rapidly and bond to the mouth making it almost impossible to swallow. Saliv will separate any solidified product in several hours. Prevent the patient from swallowing any separated mass.
Symptoms:	See Section 11.
Notes to physician:	Surgery is not necessary to separate accidentally bonded tissues. Experien has shown that bonded tissues are best treated by passive, non-surgical fir aid. If rapid curing has caused thermal burns they should be treated symptomatically after adhesive is removed.

#### Potential Health Effects/Symptoms

Cyanoacrylates have been reported to cause allergic reaction but due to rapid polymerization at the skin surface, an allergic response is rare. Cyanoacrylates generate heat on solidification. In rare circumstances a large drop will burn the skin. Cured adhesive does not present a health hazard even if bonded to the skin.
Eye contact:	Irritating to eyes. Causes excessive tearing. Eyelids may bond.
Ingestion:	Not expected to be harmful by ingestion. Rapidly polymerizes (solidifies) and bonds in mouth. It is almost impossible to swallow.
